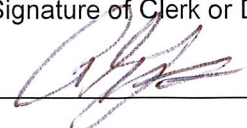

INDEPENDENT AUDITOR'S REPORT

To the Corporation of the City of Brantford

Qualified Opinion

We have audited the statement of campaign income and expenses and the calculation of surplus or deficit of Kevin Davis, Candidate (the 'Candidate') for the campaign period from May 2, 2022 to December 31, 2022 relating to the election held on October 24, 2022 (together "the Financial Statement – Form 4").

In our opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* paragraph, the accompanying Financial Statement – Form 4 consisting of the campaign income and expenses and the calculation of surplus or deficit of the Candidate for the period from May 2, 2022 to December 31, 2022 is prepared, in all material respects in accordance with accounting treatment prescribed by the Municipal Elections Act, 1996 (Section 88).

Basis for Qualified Opinion

Due to the inherent nature of the transactions of the Candidate, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these amounts was limited to the amounts recorded in the records of the Candidate and we were not able to determine whether any adjustments might be necessary to campaign income and expenses, surplus or deficit for the period from May 2, 2022 to December 31, 2022.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statement – Form 4* section of our report. We are independent of the Candidate in accordance with the ethical requirements that are relevant to our audit of the financial statement in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Emphasis of Matter – Basis of Accounting and Restriction on Use

We draw attention to the basis of accounting which is in accordance with accounting treatment prescribed by the Municipal Elections Act, 1996 (Section 88). The Financial Statement – Form 4 is prepared to assist the Candidate to meet the requirements of the Municipal Elections Act, 1996 (Section 88). As a result, the financial statement – Form 4 may not be suitable for another purpose. Our report is intended solely for the Candidate and the City of Brantford and should not be used by parties other than the Candidate and the City of Brantford. Our opinion is not modified in respect of this matter.

Responsibilities of the Candidate for the Financial Statement – Form 4

The Candidate is responsible for preparation of the Financial Statement – Form 4 in accordance with the with accounting treatment prescribed by the Municipal Elections Act, 1996 (Section 88) and in the prescribed form issued by the Ministry of Municipal Affairs, and for such internal control as the

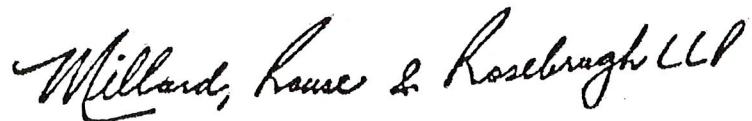
Candidate determines is necessary to enable the preparation of the Financial Statement – Form 4 that is free from material misstatement, whether due to fraud or error.

Auditor's Responsibilities for the Audit of the Financial Statement – Form 4

Our objectives are to obtain reasonable assurance about whether the Financial Statement – Form 4 as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the Financial Statement – Form 4.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the Financial Statement – Form 4, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Candidate's internal control.
