Change Order #4 for Wastewater Treatment Plant Contract

The Director of Engineering explained that as per the requirements in our Environmental Approval it is required that the Town of Gander complete Breeding Bird Surveys for the proposed Wastewater Treatment Plant site location prior and during the site clearing area of approximately 39 hectares.

This change is for a maximum of ten days for two qualified individuals to be on site in Gander at \$3,000 per day which excludes air travel and taxes. The maximum limit on costs the Town of Gander could incur due to this change is \$36,340, including HST.
