Introduction



A civil marriage ceremony in Ontario can be held at any location and tailored to your preferences. Whether it's a simple event at a municipal facility, an intimate gathering with loved ones, or a personal ceremony followed by a larger celebration, the Town of Grimsby and its officiants will ensure that your ceremony receives the attention and care it deserves.

Applicant Checklist



Book your civil marriage ceremony with the Town of Grimsby using the following checklist.

-  Review our Civil Marriages Guide.
-  Contact the Office of the Clerk to confirm Officiant availability for your preferred ceremony date and time.
-  Book an appointment to book and pay for your ceremony.
-  If you select a location other than Town Hall, book and pay for your Town facility through Community Servies online. Please discuss this option with your officiant to confirm availability.
-  Make arrangements for two (2) witnesses. Witnesses can be provided by the Town at the request of the applicant(s). Additional fees will apply.
-  Obtain a valid marriage licence in Ontario (valid for ninety (90) days from issuance). Should you wish to receive your licence from the Town of Grimsby, please apply online on the Town's website, Marriage Licence webpage and book an appointment for issuance.
-  Arrange for any desired music, videographer, or photographer. All equipment is the responsibility of the celebrants.
-  Advise your Town Officiant of your choice of vows at least one week prior to your ceremony date.

Civil Marriage Guidelines



General

- Civil marriage ceremonies may be conducted during select regular office hours (Monday to Friday, 10:00 am to 3:00 pm) or at off-site Town facilities at the discretion of the officiant. Additional fees will apply for off-site Town facilities.
- A civil marriage ceremony shall incorporate all mandatory declarations under the Marriage Act, with various options being made available through the Clerk's Office.
- Civil marriage ceremonies shall be secular, with no reference to God, a Supreme Being, or any religious connotations.
- Celebrants for a civil marriage ceremony agree to compensate the Town of Grimsby for any loss or damage caused by their guests.
- Celebrants shall agree that the Town of Grimsby will not be held responsible for personal injury or damage, nor for the theft or loss of any personal property of anyone attending the civil marriage ceremony.
- Celebrants shall be responsible for the conduct and supervision of all ceremony attendees and ensure that all event regulations are followed.

Booking a Civil Marriage Ceremony

- Scheduling a civil marriage ceremony should be made with the Clerk's office at least two to four (2-4) weeks prior to the intended ceremony date. All efforts will be made to accommodate your desired ceremony date and time.
- Civil marriage ceremony fees are detailed in the Town of Grimsby Fees and Charges By-law.
 - Facility fees are also detailed in the Town of Grimsby Fees and Charges By-Law. Please refer to [Rates and Fees | Town of Grimsby](#) for more information.
- A civil ceremony booking shall be confirmed once the officiant availability has been confirmed and payment received in full.
- Celebrants shall advise the Clerk's office of any accessibility requirements prior to the date of the ceremony.

Civil Marriage Guidelines Cont'd



Witnesses and Interpreters

- Two (2) witnesses must be present at a civil marriage ceremony. The official witnesses must be fourteen (14) years of age or older.
- Municipal staff may act as witnesses, subject to an additional fee.
- The parties must supply an interpreter if they do not speak English and require language assistance if the Clerk/Designate deems it necessary.
- The interpreter cannot be one of the witnesses. Interpreters will be required to sign a declaration.

Location and Facilities (see page 10 for details)

- Town Hall will be available for a maximum of 45 minutes per ceremony. Rental fees will apply if the ceremony is held outside of Town Hall. Off-site Town facilities may have a longer rental period. Currently, the Town does not permit receptions in our parks after the ceremony. **Outdoor spaces remain open to the public.**
- Using confetti, rice, bubbles, candles, incense, etc., inside any municipal facility or on municipal property is prohibited. Food of any kind is prohibited at Town Hall. For food at other Town facilities, please discuss with your officiant and/or Community Services. Any breach of this provision shall result in the imposition of a cleaning fee.

Ceremony

- Celebrants are encouraged to arrive fifteen (15) minutes before the ceremony.
- Personal vows, readings and/or music may be permitted in addition to the mandatory declarations, subject to the approval of the Clerk's office.
- Cell phones must be turned off or silenced before the commencement of the ceremony.
- To maintain the ceremony's dignity, personal attire should be appropriate for the occasion, although formal attire is not required.

If any member of the party to be married and their witnesses are more than 15 minutes late, the Town reserves the right to reschedule the ceremony for another date and time. If the parties choose not to reschedule, fees are not refunded.

Civil Marriage Guidelines Cont'd



Decorations, Flowers, Music and Photography

- Music appropriate to the dignity of the occasion may be permitted and must be identified to the Clerk's office upon booking. Celebrants are responsible for providing the equipment.
- Photographs are permitted during the formal ceremony, subject to the discretion of the Officiant.
- Town-owned grounds may be used for photographs if the ceremony is held at a municipal facility.
- Celebrants may place floral arrangements and/or other decorations at Town Hall five (5) minutes before the ceremony under the approval of the Clerk's office. Decorations shall be removed immediately following the conclusion of the ceremony.

Drugs, Alcohol and Stimulants

- If the Officiant believes that alcohol and/or other stimulants have been used, the ceremony will not proceed.
- The Officiant has the authority to refuse to solemnize the civil marriage of any person(s) if they have reasonable grounds to believe the person(s) lack the capacity to marry by reason of being under the influence of alcohol and/or other stimulants.
- Smoking and vaping are prohibited in municipal facilities and on municipal property.
- Alcoholic beverages are prohibited in all municipal facilities and on municipal property.

If you are considering serving alcohol at the Carnegie Building, please consult with Community Services regarding the requirements for obtaining a liquor licence.

Common Questions



What documents are required for a civil marriage ceremony?

The applicants are required to obtain an Ontario marriage licence before the civil marriage ceremony. The licence is valid for ninety (90) days following the date of issue. A marriage licence may be obtained from the Town of Grimsby or any municipality in Ontario. To reserve the date and time of the civil marriage ceremony, the applicants must book an appointment with the Clerks department to pay for their ceremony.

Who may officiate the wedding?

In the Town of Grimsby, the Clerk and their designate(s) are appointed Officiants and may perform civil marriage ceremonies.

Can a friend or family member officiate the civil marriage ceremony?

In Ontario, a Judge or Justice of the Peace, Town or City Clerk and/or Religious Official may perform a civil marriage ceremony. A friend or family member who does not hold the above title cannot perform a legal ceremony. Subject to the approval of the Clerk/Designate, a friend and/or family member may join in the formal ceremony to perform a reading.

Can we get married on the weekend?

No. Currently the Town of Grimsby does not offer weekend ceremonies.

Does the Town of Grimsby offer "same-day service" for a ceremony?

The Town of Grimsby does not provide same-day service for civil marriage ceremonies. To ensure availability, requests should be submitted at least two to four (2-4) weeks before the desired ceremony date, or as otherwise arranged based on the Officiant's schedule. Please note that a marriage licence cannot be issued on the same day as the civil marriage ceremony.

Common Questions Cont'd



Are witnesses required for a civil marriage ceremony?

Yes, all celebrants require two (2) witnesses present during the ceremony. Witnesses must be at least fourteen (14) years of age and speak English or have a translator present. If no witnesses are available, the Town may supply one (1) or two (2) witnesses upon request. Additional fees will apply per witness.

May we include a reading from the Bible or a blessing during the ceremony?

The Officiant may not perform any type of religious ceremony in keeping with the spirit of the Marriage Act, which requires ceremonies to be "non-denominational."

Who registers our civil ceremony?

After the ceremony, all parties must sign the statement of marriage, record of solemnization (to be retained by the celebrants) and the Town's civil marriage ceremony record. The Officiant will ensure all documentation is forwarded to the Office of the Registrar General in Thunder Bay within two (2) business days to register your marriage with the Province of Ontario.

Marriage Certificate and Name Change



Receiving a Marriage Certificate from Service Ontario

A Marriage Certificate is the legal record of a marriage. It lists the date, location of the marriage and the names of the people who were married.

Before you can apply to obtain a Marriage Certificate, the marriage needs to be registered by the Province of Ontario. The officiant who performed the marriage will do this by sending a complete and signed marriage licence to the Office of the Registrar immediately following the ceremony. The registration process takes approximately 8-10 weeks after the license is filed; once processed, a Marriage Certificate can be ordered.

A Record of Solemnization is not the same as a Marriage Certificate.

To order a Marriage Certificate, wait 8 to 10 weeks following the ceremony and then complete the forms available at www.serviceontario.ca

Obtaining a Marriage Certificate is not required; however, individuals need this document in order to:

- Provide legal proof that they are married
- To apply for certain social benefits
- Settle an estate
- To assume your partner's last name

Changing Your Last Name After Marriage

It is not required to change your last name after marriage. A new name can be assumed straight away; however, for changes to official documents, a Marriage Certificate will be required for proof of marriage.

Centennial Park

One of Grimsby's largest green spaces, this park holds the perfect spot for an outdoor ceremony amongst its beautiful willow trees.

Capacity: 30 people.

Seating is not available.

Cost: \$420.36 + park rental fee and insurance



Carnegie Building

A historic building and former library with hardwood floors, large windows and plenty of character.

Capacity: 30 when using tables and chairs

Amenities: Kitchenette, tables and chairs

Cost: \$420.36 + facility rental fee (by the hour) and insurance



The Pumphouse Gazebo

This is for the Gazebo only, which offers lake views.

Capacity: 20 people.

Seating is not available.

Cost: \$420.36 + park rental fee and insurance



Accessibility varies for each Town of Grimsby location. Please inquire upon booking.

Cancellation and Inclement Weather Policy

Cancellation Fees

Ceremonies at Town Hall

A cancellation fee of \$130.10 will apply to any civil ceremony cancelled with less than two (2) business days' notice.

Ceremonies at Other Town Facilities, Including Parks

1. A cancellation fee of \$130.10 will apply to any civil ceremony cancelled with less than two (2) business days' notice, and;
2. Facility and park rental fees are subject to the following cancellation schedule:
 - Sixty (60) or more days' notice: no charge
 - Fourteen (14) to fifty-nine (59) days' notice: 25% of the rental fee
 - Three (3) to thirteen (13) days' notice: 50% of the rental fee
 - Less than three (3) days' notice: 100% of the rental fee, including any applicable fees.

Inclement Weather

In the event of inclement weather that prevents the ceremony from taking place outdoors, the Town will pre-arrange a back-up location in the Council Chambers at Town Hall (160 Livingston Avenue), at no charge, for a 30-minute period.

The decision to relocate due to weather conditions will be made by the Officiant approximately four (4) to six (6) hours prior to the scheduled ceremony time. Couples will be notified of the change by email from their Officiant.

Civil Ceremony Vows



The Clerk's Office offers four pre-written civil ceremony options. Couples are welcome to personalize their chosen ceremony, as long as the required legal wording—highlighted in **bold**—remains unchanged. You may also include your own personal vows in any of the ceremony options provided.

If you would like to use different vows, please speak with your officiant to ensure they can be included in the ceremony.

At the applicants' request, the Clerk's Office will utilize alternative gender-neutral language throughout the ceremony.

APPENDIX A

We are gathered together to witness the formal joining of Spouse 1 and Spouse 2 in legal matrimony according to the custom and law prevailing by the Government of the Province of Ontario.

Municipal Clerk to 1st person: Spouse 1, repeat after me, please:

"I do solemnly declare / that I do not know / of any lawful reason / why I, Spouse 1 / may not be joined / in matrimony to Spouse 2."

Municipal Clerk to 2nd person: Spouse 2, repeat after me, please:

"I do solemnly declare / that I do not know / of any lawful reason / why I, Spouse 2 may not be joined / in matrimony to Spouse 1."

Municipal Clerk to 1st person: Spouse 1, repeat after me, please:

"I call upon / these persons here present / to witness that I Spouse 1 / do take you Spouse 2 / to be my lawful wedded (husband/wife/spouse/partner)."

Municipal Clerk to 2nd person: Spouse 2, repeat after me, please:

"I call upon / these persons here present / to witness that I Spouse 2 / do take you Spouse 1 / to be my lawful wedded (husband/wife/spouse/partner)."

Municipal Clerk to 2nd person: Spouse 1, repeat after me, please:

"With this ring I thee wed / I shall love, honour and cherish thee / and this ring shall be / the symbol of my love."

Municipal Clerk to 2nd person: Spouse 2, repeat after me, please:

"With this ring I thee wed / I shall love, honour and cherish thee / and this ring shall be / the symbol of my love."

I, Municipal Clerk, by virtue of the powers vested in me by the Marriage Act, do hereby pronounce you Spouse 1 and Spouse 2 to be (husband and wife / partners in life / spouses / married).

I wish you a long life, prosperity, and may the vows you made to each other today, sustain you forever.

You may kiss.

APPENDIX B

This couple has come here today to be joined in marriage. They have invited us to share in this celebration as they affirm their love before us and enter into the joys of marriage.

Marriage is not a single event but rather a developing process which is not to be undertaken recklessly or irresponsibly but rather maturely and honestly. Marriage is the faithful union between two persons, the result of which is the formation of a family unit whose members shall help, support and enjoy each other in good times and in bad times. It is this relationship these two persons wish to have declared and celebrated today.

Municipal Clerk to 1st person: Spouse 1, repeat after me, please:

"I do solemnly declare / that I do not know / of any lawful reason / why I, Spouse 1 / may not be joined / in matrimony to Spouse 2."

Municipal Clerk to 2nd person: Spouse 2, repeat after me, please:

"I do solemnly declare / that I do not know / of any lawful reason / why I, Spouse 2 / may not be joined / in matrimony to Spouse 1."

Municipal Clerk to 1st person: Spouse 1, repeat after me, please:

"I call upon these persons here / to witness that I Spouse 1 / do take you Spouse 2 / to be my lawful wedded (husband/wife/spouse/partner)."

Municipal Clerk to 2nd person: Spouse 2, repeat after me, please:

"I call upon these persons here / to witness that I Spouse 2 / do take you Spouse 1 / to be my lawful wedded (husband/wife/spouse/partner)."

APPENDIX C

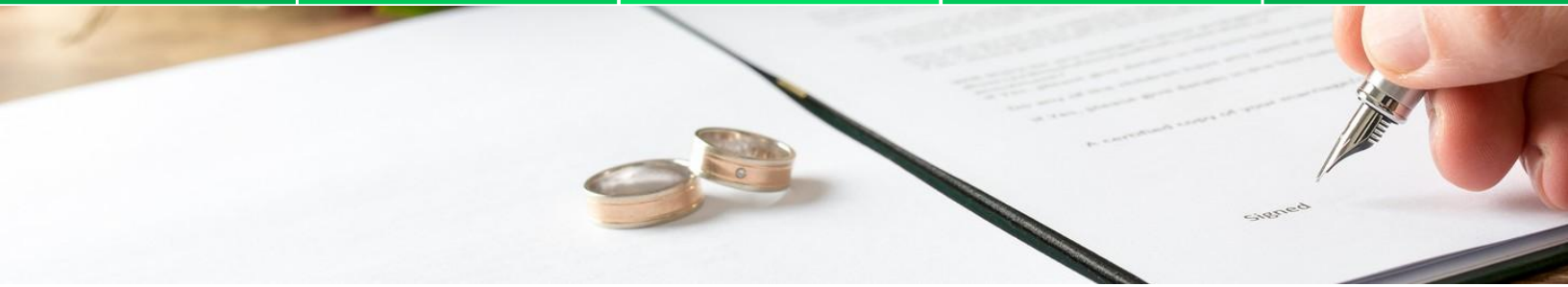

1. Reach Out to the Town of Grimsby Clerk's Office

First, contact the Clerk's Office to check on available dates for your civil ceremony. We're happy to help you find the perfect time to celebrate your special day. Call us at (905)945-9634 or email us at marriage@grimsby.ca.

2. Choose Your Ceremony Location

You can choose to have your civil ceremony at Town Hall, or at one of our Town facilities. Whether you prefer the simplicity of Town Hall or a more personal setting, we're here to guide you through the options so you can select the one that feels right for you.

3. Apply for Your Marriage License

To make everything official, you'll need to apply for a marriage license. You can apply online with the Town of Grimsby at www.grimsby.ca or you can apply at another municipality. Please note if you apply at a different municipality, you will need to bring your marriage licence to your officiant at least 5 business days before your ceremony.

4. Book and Pay for Your Ceremony

Once you've confirmed your date and location, it's time to book your civil ceremony and handle the payment.

5. Pick Your Vows

Now comes the fun part! Take a look at the different vow options we've provided, or feel free to add your own personal touch.
