



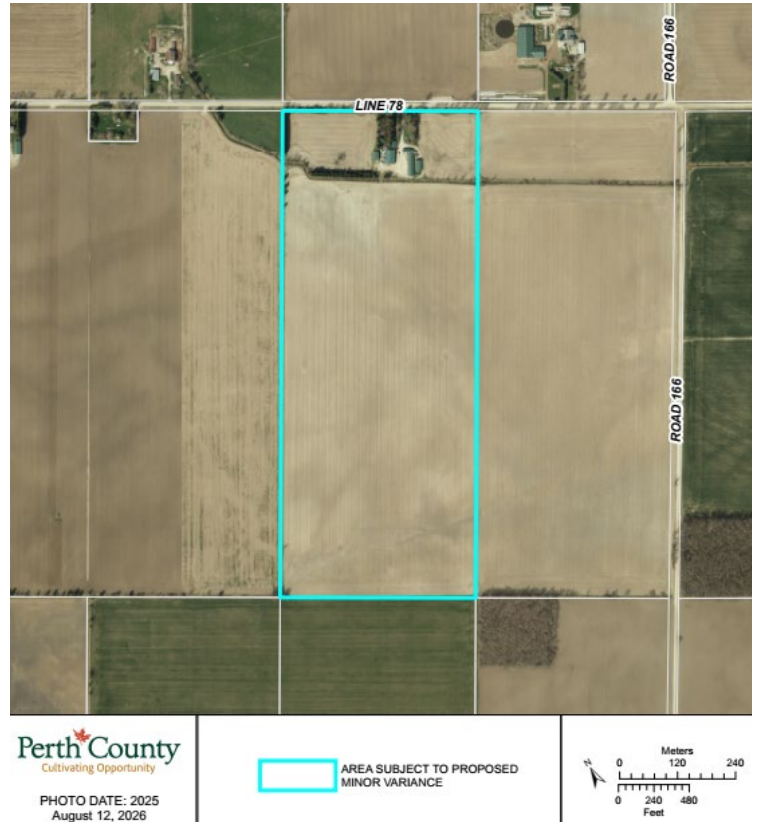

Public input on applications is invited. Pursuant to Section 45 of the *Planning Act*, the Committee of Adjustment for the Municipality of North Perth invites you to consider applications for minor variance and/or to forward written comments prior to the hearing.

**RE: AN APPLICATION BY:** Hugh Haverkamp for HK Poultry Farms Ltd.  
**LOCATION OF PROPERTY:** Lot 9, Concession 6, Elma Ward, Municipality of North Perth (6355 Line 78)

**PURPOSE OF APPLICATION:** The subject application is requesting relief from Section 6.4.1 and Section 6.4.2 of the North Perth Zoning By-law to reduce the minimum required setback for Minimum Distance Separation II (MDS II) for a Type A land use (House) from 337 m (1,105 ft) to 305 m (1,000 ft) to facilitate the construction of a 1,468 m<sup>2</sup> Layer (chicken) barn. The application is also requesting the a reduction to the minimum required setback for Minimum Distatance Seperation I (MDS I) to both a neighbouring barn and manure storage from 397 m (1,302 ft) to 310 m (1,017 ft) to facilitate the construction of a residential dwelling for on farm labour housing.

**PUBLIC HEARING:** You are entitled to participate in this public hearing to express your views about this application or you may be represented by counsel for that purpose. If you are aware of any person interested in or affected by this application who has not received a copy of this notice you are requested to inform that person of this hearing.



If a person or public body does not participate in this public hearing to the North Perth Committee of Adjustment before the Decision is made, the person or public body is not entitled to appeal the decision of the North Perth Committee of Adjustment to the Ontario Land Tribunal.

**FAILURE TO PARTICIPATE IN THE HEARING** If you do not participate in this public hearing it may proceed in your absence and, except as otherwise provided in *The Planning Act*, you will not be entitled to any further notice in the proceedings.
