1. PURPOSE

- 1.1. The purpose of this policy is to establish clear and consistent procedures for naming streets and renaming existing streets within the Town of Wasaga Beach. This ensures uniformity in street names, minimizes confusion, and supports the effective delivery of emergency services, postal services, and other essential municipal functions.

2. SCOPE

- 2.1. This policy applies to all public and private streets or roads within the Town of Wasaga Beach, as well as any requests for renaming existing streets or roads. The approval of street names is the responsibility of the Town through the passage of a by-law enacted by Council. Suggestions for street names may come from citizens, proponents of development applications, Town staff, or members of Council. This policy does not apply to streets or roads under the authority of the Ministry of Transportation or County of Simcoe.

3. DEFINITIONS

“Approved Street Name List”: A maintained inventory (referred to as Schedule “D”) of the street names officially pre-approved by the Council of the Town, from which names may be selected for new or renamed streets.

“Citizen”: An individual or organization who submits a request for the naming or renaming of a street.

“Council”: Council of the Corporation of the Town of Wasaga Beach.

“Director”: The Director of Planning or designate.

“Duplication”: The occurrence of a proposed street name that is identical or substantially similar in spelling or pronunciation to an existing street name in the Town or an adjacent municipality, which is prohibited to prevent confusion.

“Municipal Address By-law”: A By-law that regulates the assignment and display of civic addresses within the Town.

“Proponent”: A Developer who submits a request for the naming or renaming of a street as part of a development application.

“Public Street”: A street or road owned and maintained by the Town and accessible for public use.

“Private Street”: A street or road not owned by the Town but serving properties that are numbered according to the Municipal Address By-law and thus requiring official naming for consistency and emergency response purposes.

“Street Name List”: A maintained inventory (referred to as Schedule “E”) of the street names already in use by the Town, and that are reserved and no longer available to be selected for new or renamed streets.

“Town”: Shall mean the Corporation of the Town of Wasaga Beach.

4. STREET NAMING AUTHORITY

- 4.1. The naming of public streets shall be the sole responsibility of the Town.
- 4.2. The Town has sole responsibility over naming private streets or roads where individual properties are numbered according to the Town’s Municipal Address By-law, as may be amended.
- 4.3. This includes private roads within a Plan of Condominium.
- 4.4. The Town has sole responsibility over renaming all existing public and private roads.

5. GENERAL PRINCIPLES

- 5.1. All public and private streets or roads within the Town, including private and/or commercial roads, shall have a street name.
- 5.2. All street names shall be unique. No street name in the Town shall be duplicated and duplication of street names with abutting municipalities is to be avoided.
- 5.3. Proponents of development applications shall receive Schedule “D” and Schedule “E” from the Town to assist them in the selection of potential suitable street names. Proponents will provide one alternate street name and suffix for each proposed name in the event of duplication.

6. INVENTORY OF ACCEPTABLE STREET NAMES

- 6.1. The Director of Planning shall compile and vet all proposed street names for suitability, appropriateness and compliance with this policy. The Director will then provide recommendations to Council for approval.
- 6.2. The Director of Planning shall maintain the “Approved Street Name List” (Schedule “D”) and the “Street Name List” (Schedule “E”).

7. OTHER STREET NAMES

- 7.1. The “Approved Street Name List” (Schedule “D”) are those other names that have been vetted and pre-approved by Council for use.
- 7.2. Council considers and pre-approves street names in the “Approved Street Name List” (Schedule “D”) at its discretion and provided they do not conflict with existing street names in Schedule “E”.

8. STREET NAME APPROVAL/ASSIGNMENT PROCESS

- 8.1. The process for approving a street name(s) is as follows:
 - 8.1.1. Any Citizen, Proponent, member of Council and Advisory Committees can make an application to add a Street Name to the Approved Street Name List or to rename an existing street.
 - 8.1.2. The application shall be submitted to the Director and must include a sworn declaration for the proposed street name(s), a brief but complete explanation for the name(s).
 - 8.1.3. The Director will review the application for conformity to the criteria details outlined in this Policy.
 - 8.1.4. If the proposed name/explanation does not meet the Policy Criteria, the applicant will be advised in writing, and the name will not be brought before Council for consideration.
 - 8.1.5. If the proposed name/explanation meets the Policy Criteria, the Director will bring a recommendation report to Council for consideration. If approved by Council the name(s) are included in Schedule "D" or Schedule "E", as is required. If it is a Proponent's request for a development application, the name(s) may be reserved for use for the Proponent's development application.
 - 8.1.6. Despite 8.1.5 above, the Town may withdraw approval of name(s) where a Proponent's development application is dormant.
- 8.2. It is expected that a Proponent will as a minimum use one (1) pre-approved street name from Schedule "D" for their development application. The process for an approved street name is as follows:
 - 8.2.1. The Proponent reviews the Approved Street Name List (Schedule "D" for their street name(s) selection and identifies their selection in the application form.
 - 8.2.2. Staff confirm that the selected name has not be pre-assigned to another development application, and if not, includes the Proponent's selection in the staff report to Council.
 - 8.2.3. If for some reason the Proponent fails to make a selection from Schedule "D" a name will be assigned by the Director.

9. COUNCIL DISCRETION

- 9.1. Council may, at any time, direct that a specific street name be used for a specific street.

10. GENERAL POLICIES FOR THE APPROVED STREET NAME LIST

The following general policies apply when considering adding a name to the approved street names in Schedule "D".

10.1. Names Honouring Those Who Have Served or Given Their Life in Public Service

- 10.1.1. The Town will facilitate the naming of streets after Town residents who have lost their lives while serving within the Canadian Armed Forces or those who have served in the Canadian Armed Forces. In addition, the Town may also include the name of those who have lost their lives within emergency services, with the consent of the individual's immediate surviving family, where possible.
- 10.1.2. Special signage containing the Poppy symbol is to be used for all Veteran Street names.

10.2. Names Honoring Individuals – Local Historical reasons, National or International, or for Community Service

- 10.2.1. Council may approve, or a proponent may request the approval of a name for a street, which identifies a specific individual. Generally, such a name will be of historic importance to the Town or be a name which is of importance either nationally or internationally or lastly be a name of an individual who has been of public service to the Town or broader Community. A written description of the individual's contribution to the Town, or broader Community explaining why the honour should be given, shall be submitted by the Proponent or Citizen. Staff shall research names proposed by Council.

10.3. Names that reflect the Town's Recreational or Heritage/Nature

- 10.3.1. Council may approve, or a Proponent or Citizen may request the approval of a name for a street which reflects the Town's recreational heritage/nature. The Proponent or Citizen shall submit a written description of the proposed name and its linkage to the area. Staff shall research names proposed by a Proponent or Citizen.

10.4. Other Names

- 10.4.1. Other appropriate street names are names that promote pride in the Town, acknowledge local heritage and history, and recognize unique features and geography.
- 10.4.2. Proposed names should meet one of following:
- 10.4.3. Street names:
- Commemorate local history, places, events, culture;
 - Strengthen neighbourhood identity to reflect the character of the area;
 - Recognize native wildlife, flora, fauna, natural features;

- Recognize communities that contribute to the public life of the Town.
- 10.4.4. Street names that represent specific themes are encouraged as they are easily recognizable for emergency services and provide consistency in large developments.

11. STREET NAME GUIDELINES

Street naming guidelines have been developed to promote the orderly naming of streets. When naming a street, in addition to the General Principles as stated in Section 5, the following shall be adhered to:

11.1. Ease of Spelling and Pronunciation

- 11.1.1. All street names should be easily pronounced and use conventional spelling to avoid communication complications during an emergency.
- 11.1.2. Similar spelled or pronounced street names shall not be considered to avoid communication complications during an emergency.

11.2. Two Word Street Names

- 11.2.1. Except for an individual provided for in Section 10.1, proposed street names shall consist of only an individual's surname unless additional identification is necessitated by the Town to prevent duplication with an existing street name in the Town and surrounding local municipalities.

11.3. Individuals

- 11.3.1. Streets named after individuals where the full name is being used shall be a posthumous honour and Council shall consider such names provided that a written consent is obtained from the individual's immediate surviving family, where possible. The honouring of a living international/national public figure requires their consent.

11.4. Street Name Characteristic

- 11.4.1. The use of hyphens or special characters is prohibited in street naming. Apostrophes should be avoided whenever possible.
- 11.4.2. No street name shall exceed 25 characters, excluding the suffix.
- 11.4.3. Street name type designation suffixes are outlined in Schedule "C".
- 11.4.4. This policy ensures that the above-mentioned criterion is met and that there is a standard street name signage across the Town.

11.5. Street Names to Avoid

- 11.5.1. Names that conflict with other street names within the Town or abutting municipalities.
- 11.5.2. Names that could be construed as advertising a particular business, product or brand.
- 11.5.3. Cumbersome, corrupted, modified names, discriminatory or derogatory names from the point of view of race, sex, colour, creed, political affiliation or other social factors.
- 11.5.4. Names with any sexual overtones, inappropriate humour, parody, slang or double meaning.
- 11.5.5. Names that have a secondary negative or offensive connotation.
- 11.5.6. Street names are spelled differently but sound alike (e.g. Lee Street and Leigh Street) or have similar pronunciation but are spelled differently (e.g. Heirloom Street could be pronounced with 'H' dropped (Eirloom Street).
- 11.5.7. Use of complex words.
- 11.5.8. Names with hyphens, apostrophes or dashes are discouraged and only considered on a case-by-case basis provided another criterion is met.

12. APPLICATION FOR THE NAMING / RENAMING OF STREETS

- 12.1. All requests for the naming and renaming of a street within the Town shall be submitted using the Street Naming Application Form and Sworn Declaration, referenced in Schedule "A" and Schedule "B".
- 12.2. The Street Naming Application Form shall be submitted to the Director. In the case of an existing street proposed to be renamed, the payment of the application fee as per the Town's Fees and Charges By-law. Proponents of renaming existing street may also have to pay additional fees related to revising existing property owner municipal addressing.
- 12.3. Only complete applications using Schedule "A" will be accepted and reviewed by staff for recommendation to Council.

13. PRIORITY FOR SELECTION OF STREET NAMES

- 13.1. In assigning street names, a Proponent or staff shall utilize names from the Approved Street Name List (Schedule "D") when selecting names for a proposed street. Items 1 through 3 below are the first three categories referenced in Section 10 and the priority of selection is as set below.
 - 13.1.1. Names Honouring Those Who Have Served Their Country or who have given their life in public service.
 - 13.1.2. Names Honouring Individuals – Local Historical, National or International or Community Service.
 - 13.1.3. Names that reflect the Municipality's Recreational or Heritage/Nature.

14. EFFECTIVE DATE

- 14.1. This Policy shall come into force on the day it is approved by the Council of the Town.

15. POLICY REVIEW AND PROCEDURE

- 15.1. This policy will be reviewed every five years or as required to ensure that it continues to address the needs of the Town with respect to Street Naming. The Director is authorized to make minor administrative amendments to this policy as may be needed.

SCHEDULE "C": STREET NAME TYPE DESIGNATIONS

Generally, street names shall contain the suffix "Street", "Avenue", "Road" or "Drive". The suffix "Road" shall only be utilized for major collector or arterial streets (i.e. those streets that are, or will be, designated as collector or arterial roads within the Town or County's Official Plan). For other proposed suffixes, the following definitions shall be used:

"Avenue" shall mean a street which runs in the East and West direction and is longer than three hundred and five metres in length.

"Boulevard" shall mean a wide street, usually having a median or promenade and lined with trees.

"Court" shall mean a permanently closed street such as a cul-de-sac which is less than three hundred and five metres in length.

"Crescent" shall mean a crescent shaped street which begins and circles back to terminate on the same street.

"Drive" shall mean a winding thoroughfare which continues through to other roads and is longer than three hundred and five metres.

"Lane" shall mean a public way that provides only a secondary means of access to a lot and which is not intended for general traffic circulation.

"Parkway" shall mean an unusually wide thoroughfare in residential neighborhoods divided by a landscaped centre island.

"Place" shall mean a permanently dead ended street which is less than 60.0 metres in length.

"Road" shall mean a thoroughfare that is frequently used, has heavy traffic volumes and runs in any direction for more than three hundred and five metres.

"Street" shall mean a street which runs in a North and South direction (such as Pearl Street) and is more than three hundred and five metres in length.

"Trail" shall not be used as a suffix due to confusion with the current Trails Network.

"Way" shall mean a narrow street with seven metres or less in width of hard surface.
