TOWN OF WASAGA BEACH NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING FOR A PROPOSED ZONING BY-LAW AMENDMENT (FILE NO. Z01026)

The Town of Wasaga Beach has received a complete application for a proposed Zoning By-law Amendment pursuant to the provisions of the *Planning Act*, R.S.O. 1990, c. P.13, as amended. This application is deemed complete for the purpose of the *Planning Act*.

Council has not yet taken a position on the application and notice is being circulated in order to obtain public and agency input.

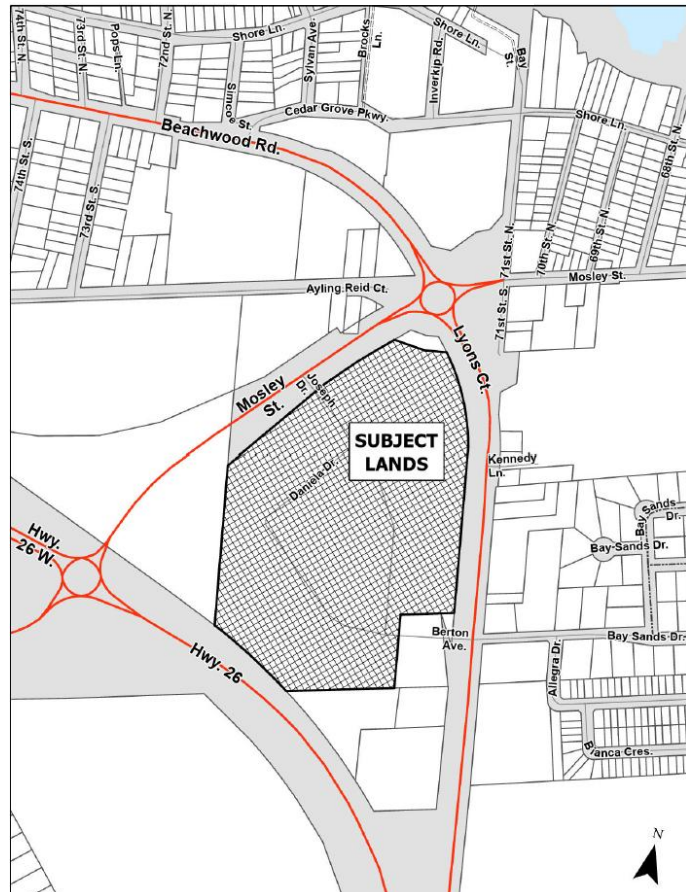

THE SUBJECT LANDS are municipally addressed as 88 Lyons Court, and legally described as NOTTAWASAGA CON 3 PT LOT 33 RP 51R32826 PT PART 1.

THE PROPOSED ZONING BY-LAW AMENDMENT is proposing to re-zone a portion of the subject lands from the “District Commercial Holding” (CD-H) Zone, to the “Residential Type 4 Exception” (R4-XX) Zone with site specific provisions.

THE PURPOSE AND EFFECT of the proposed Zoning By-law Amendment is to facilitate the construction of an 8-Storey residential apartment consisting of 124 rental units. The residential apartments are situated within the first 7 storeys, while the 8th storey is proposed as indoor and outdoor amenity space along with rooftop mechanical equipment features to accommodate the staircase and elevator accessing the 8th floor. A total of 125 parking spaces including 6 barrier free parking spaces are proposed

ORAL AND WRITTEN SUBMISSIONS:

Any person may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Zoning By-law Amendment.

If a specified person or public body would otherwise have an ability to appeal the decision of the Town of Wasaga Beach to the Ontario Land Tribunal, but the specified person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Wasaga Beach before the by-law is passed, the specified person or public body is not entitled to appeal the decision.

If a specified person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Wasaga Beach before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Please note that specified persons as defined in the *Planning Act* does not include members of the general public.

NOTICE TO LANDLORDS AND CONDOMINIUM CORPORATIONS: for any land that contains seven (7) or more residential units, the landowner is requested to post this Notice in a location that is visible to all of the residents.
